APEC Vietnam

Next year will mark the second time Vietnam will host APEC since acceding to the group in 1998; it first hosted in 2006. Vietnamese officials consider Vietnam's APEC chairmanship to be its most important diplomatic event to take place over the next decade. That is due, in part, to APEC's strategic importance to Vietnam; nineteen APEC economies participate in free trade agreements with Vietnam and its trade with APEC economies represents 79 percent of the country's total trade. APEC economies also invest significantly in Vietnam, representing nearly 80 percent of total foreign direct investment.
