#### ABAC 2011 Themes and Priorities

For 2011, ABAC has created four working groups that reflect the Council's priority areas: Regional Economic Integration; Small, Medium, and Micro Sized Enterprises and Entrepreneurship; Sustainable Growth; and Finance and Economics. ABAC also created a group to specifically focus on outreach and advocacy. At ABAC I the Council succeeded in finalizing the overall 2011 work plan, including identifying key outcomes from each ABAC working group, identifying owners for each issue, as well as developing advocacy strategies for each key issue.

The Regional Economic Integration Working Group will work towards the ultimate goal of establishing a Free Trade Area in Asia Pacific (FTAAP). Focus will be given to supporting APEC's trade & investment agenda, identifying and defining building blocks for 21st century trade agreements such as the Trans Pacific Partnership, and making recommendations on regulatory convergence as well as value chain and supply chain choke points

## U.S. Private Sector Industry Issues

These issues will be discussed in more detail during ABAC II in Seoul this April.

Intellectual Property Rights - NCAPEC collaborated with the US Chamber of Commerce to organize the second annual Intellectual Property Rights Experts' Group (IPEG) Dialogue with the Private Sector on March 3. The event provided an opportunity for the private sector to update government IP experts on the latest developments in online counterfeiting and piracy. In a second panel, private sector representatives provided recommendations on policies that facilitate the development of cutting edge technologies in pharmaceutical, ag-biotech, and green technology industries.

**Energy Security** - Building on progress from 2010, ABAC will work towards a long term goal of developing a plan for enhancing energy security in APEC that could lead into an "APEC Energy Declaration." This would include suitable energy strategies and the political measures to promote those strategies. ABAC USA briefed the Council on the update to the 2008 Energy Security Framework being authored by the East-West Center.

In addition to the framework, on an ongoing basis, the ABAC's Sustainable Growth Working Group

will use the following objectives to guide its work on energy security:

- Recommend policies and initiatives to facilitate greater investment in renewable energy and the deployment of low carbon energy sources in the region
- Recommend collaboration on standard setting for energy efficiency of which smart grid as one
  of the enabler, and low carbon technologies and equipment

**Investment** - ABAC agreed to continue to place a priority on investment as an ongoing initiative within the REIWG Action Plan. As part of ABAC's work, a Public-Private Dialogue on Investment was held on 4 March under the theme of "Investing for Growth." The program covered general investment environment issues and featured panels focused on considerations specific to infrastructure investment and investor-state dispute. In the subsequent Investment Experts Group meeting, APEC members agreed to review and respond to ABAC's proposed updates to the 1994 Non-binding Investment Principles.

**Trade facilitation** - ABAC agreed to continue to advocate for the establishment of an APEC wide AEO scheme, which offers clear benefits to AEO-certified private sector entities. The objective of the effort is to encourage APEC economies to take a holistic and standardized approach to avoid a noodle bowl and redundancies with other Security programs.

**Financial Services** - For 2011, ABAC will focus on four priorities: promoting policy cooperation and convergence, enhancing capacity building, improving the efficiency and effectiveness of regional financial systems, as well as promoting inclusiveness and sustainable growth. At ABAC I the Council drafted a letter to the International Accounting Standards Board (IASB) supporting the adoption of International Financial Reporting Standards (IFRS) but highlighting potential negative impacts on SMME financing.

**Food Security** - ABAC will research major roadblocks in the food supply chain to the market. ABAC agreed to use the high-level food security meeting in Big Sky, Montana as the platform to convene a dialogue with APEC.

**Competition Policy** - ABAC held the second Competition Policy and Law Group Dialogue with the Private Sector on March 7. Five private sector representatives shared perspectives on the importance of procedural fairness in the implementation of competition policy laws. Many of the key private sector themes are included in the International Chamber of Commerce's Recommended Framework for International Best Practices in Competition Law Enforcement Proceeding.

Anti-Corruption - In response to ABAC's recommendations related to promoting the implementation of commitments on anti-corruption efforts, APEC's Anti-Corruption and Transparency (ACT) Task Force took the first step towards establishing a formal reporting mechanism by agreeing to develop a reporting template. An initial draft of the template was circulated to ACT members in D.C. and will be developed internsessionally. ABAC will also assist in the organization of a small dialogue on the margins of the next ACT meeting in San Francisco that will focus on the importance of anti-corruption efforts to the business community.

ABAC compiles these recommendations in an annual Report to Leaders which is presented to APEC Leaders prior to their annual summit in the fall of each year.
