Providing remarkable contributions to building up a middle-class in society.


Continuously supporting economic development and stabilizing society.

2009-2012 APEC SMEWG Strategic Plan

Business Environment	 Enhance the legal and regulatory framework. Facilitate market access for SMEs.
Building Management Capability & Promoting Entrepreneurship	 Improve information and guidance available to business owners. Increase opportunities for business owners to learn new skills. Encourage more business start-ups.
Market Access & Internationalization	 Increase access to information on market opportunities. Enhance market development and promotion skills. Identify and work to address barriers to SMEs' full participation in international trade/markets within the APEC region.
Innovation	 Identify factors to accelerate innovation. Promote innovation as a key competitive advantage for SMEs. Educate and facilitate SMEs' awareness, adoption and dissemination of emerging technologies.
Financing	 Increase awareness and availability of wide-ranging sources of financing, rom microfinance to venture capital. Encourage banks and financial institutions to develop policies that assist SMEs to access appropriate finance on mutually acceptable terms.
Raise awareness of Sustainable Business Practices	 Empower SMEs to recognize the value of and take advantage of the business opportunities provided by sustainable business environment. Promote sharing of sustainable business practices that would improve SME development and growth.

5	Customs clearance delays, including difficulties in navigating overly complex customs requirement and documentation	СТІ

7	Inability to protect intellectual property	CTI
8	Inadequate policy and regulatory frameworks to support cross-border electronic commerce	СТІ
9	Difficulty in taking advantage of preferential tariff rates and other aspects of trade agreements	СТІ
