# US APEC Business Coalition Meets with Foreign Leaders and US Officials on Margins of CEO Summit

U.S. business leaders and representatives met with a wide range of U.S. government officials and foreign leaders throughout the week on the margins of the CEO Summit and related meetings. The robust schedule included meetings with Prime Minister Najib of Malaysia, Prime Minister Abhisit of Thailand, Korean Trade Minister Kim and Chinese Minister of Commerce Chen. These sessions provided opportunities for companies to interact directly with APEC leaders on issue of specific interest to U.S. businesses operating in the region.

In addition, delegates had separate meetings with U.S. Secretary of Commerce Gary Locke, USTR Ron Kirk, Undersecretary of State Robert Hormats, and U.S. Representative Kevin Brady (R-TX). These meetings with U.S. leaders provided an opportunity to discuss business priorities in APEC and private sector hopes for the future direction of U.S. trade policy. Ambassador Kirk stressed the U.S.' continued commitment to promoting trade in Asia, and to APEC as a forum for pursuing equitable trading relationships with the economies of the region. He also emphasized the important role business can play in helping government make the case for trade, particularly in communicating with the small and medium business owners as well as the American public at large the advantages to be gained by trading relationships, especially in terms of jobs generated or sustained in the U.S.

## "DIVERSIFICATION AND FUTURE FUELS: A RESPONSE TO THE ENERGY SECURITY CHALLENGE IN APEC"

The workshop was the first to follow from last year's publication of the "Strategic Framework for Energy Security in APEC", authored by the East-West Center and published jointly by the Center and the ABAC. This year's workshop featured a keynote address by Mr. George Kirkland, Chevron Executive Vice President for Global Upstream, and included remarks by NCAPEC Chair Karan Bhatia and House APEC Caucus co-chair Congressman Kevin Brady (R-TX). The workshop also featured two panels of international experts on traditional and alternative fuel sources. ### APEC AND THE USA: LOOKING TO 2011 AND BEYOND DECEMBER 15, 2009

# CEO ROUNDTABLE WITH SECRETARY OF STATE CLINTON JANUARY 14, 2010

The National Center is preparing for the upcoming State Department CEO Roundtable to be held on Thursday January 14th, 2010 in Washington D.C. The roundtable presents an excellent opportunity to dialogue with top U.S. company CEOs conducting business in the APEC area, as well as top-level U.S. government officials. With the United States hosting the APEC Leader's Meetings in 2011, dialogue between the public and private sector is more critical than ever. This year's CEO Roundtable will provide a critical forum in which to recognize and encourage the private sector's role in the dynamic Asia Pacific region. ## EXECUTIVE ROUNDTABLE JANUARY 19-20, 2010

The National Center for APEC will be holding the Annual Executive Roundtable for the Japan year on January 19-20, in Half Moon Bay, California. With APEC set to be hosted in succession by the world's two largest economies, this Roundtable will be an important opportunity to set the agenda for prioritizing the issues and objectives that truly matter most to business.

The agenda will focus on key regional and global issues such as leveraging information technology to promote and sustain growth, energy and food security, health and human security, capital market development, and trade facilitation. We will also take a look at the overarching, crosscutting themes that are common to many of these sectoral concerns, including regulatory reform and harmonization, transparency issues, IPR, investment, and more.
